Grounded in years of front-line health promotion experience, she is dedicated to addressing individual, systemic and environmental factors that impact health status. Her professional activities focus on capacity building through program development and management. Her research interests include the social determinants of health, racialized women's health, and HIV risk behaviours across diverse ethnic populations.



**Dr. Gary Bloch** is a family physician with St. Michael's Hospital and Inner City Health Associates, and an Associate Professor at the University of Toronto. His clinical, program innovation, education, research, policy and advocacy interests focus on the intersection between primary care, health equity and the social determinants of health. He is a co-founder of the physician homeless services group Inner City Health Associates and the advocacy group Health Providers Against Poverty. He has developed numerous innovative clinical programs for primary care teams, and educational curricula for health care trainees, and served on an Ontario government task force targeting income security. He is an AMS Phoenix Fellow and a Senior Fellow with the Wellesley Institute.

**Dr. Maggie Hulbert** is a third year psychiatry resident and the Co-Chair of Health Providers Against Poverty, a national advocacy coalition with a broad anti-poverty mandate.



**Dr. Michaela Beder** is a psychiatrist with the ACT team at St. Michael's Hospital and with Inner City Health Associates in Toronto. Her work is focused on improving the system for, and providing care to, people who experience severe mental illness, homelessness, substance use, criminalization, and immigration related difficulties. She is the Director of Mental Health and Substance Use Care for Inner City Health Associates, and an Assistant Professor at the University of Toronto. She is the Equity and Social Justice Lead for the Department of Psychiatry's general residency program. Dr. Beder is also a community organizer working together with allies at Health Providers Against Poverty and the Healthcare for All Coalition, and on issues of immigration detention.

**Angela Robertson** is the executive director of Parkdale Queen West Community Health Centre. Parkdale Queen West is a community-based health service organization serving mid and west Toronto. Angela is dedicated to people and communities facing discrimination, poverty and marginalization and working to change those social conditions.

She is a founding member of Blockorama, which focuses on forging spaces for Black and other racialized LGBTQ+ people and allies in Toronto's Pride, and has served on numerous community Boards, including Black Coalition for AIDS Prevention, Houselink and the Stephen Lewis Foundation. Angela has been recognized for her social justice work by the YWCA, Fred Victor Centre, and Urban Alliance on Race Relations, NOW magazine and was honoured by York University in 2017 with an Honorary Doctorate of Laws degree for her social justice work.

In response to the impact of COVID-19 pandemic on racialized and low-income populations, Angela initiated and co-chair a Black Health Equity Working Group of health sector experts, leaders, practitioners, and researchers concerned with improving the health and wellbeing of Black people. For her work she was recognized by the Alliance with the Denise Brooks Equity Champion Award and the Pillar of the Pandemic recognition award from the U of T's Dalla Lana School of Public Health.

**Andrew Chung** is the executive director at Hong Fook Mental Health Association. He has worked in the non-profit sector for nearly 20 years, most of which have been in healthcare and community service organizations. Prior to Hong Fook, Andrew served as Director of Philanthropy at CAMH Foundation, leading the organization's major gifts strategy, the Recovery College portfolio, and community engagement and EDI initiatives as part of the hospital's \$500M comprehensive research capital campaign. Andrew formerly served as Board Secretary for the Asian Canadian AIDS Services, Communications and Policy Advisor at the Consortium of Agencies Serving Immigrant Professionals. He is currently at Cornell University in the Executive MBA/MSc in Healthcare Leadership dual-degree program and will graduate in in Spring 2023.



**Lucy Costa** is Deputy Executive Director at the Empowerment Council - an organization promoting the voice and human right of mental health clients. She has worked within the service user /psychiatric disability community for over two decades both at a grass roots level and in mainstream initiatives. She has produced education curricula for many stakeholders and has spoken extensively on the need for critical thinking, and ethical advocacy for service users both in psychiatric medicine and law. She has written a number of articles, blogs and is co-editor of *Madness Violence and Power: A Critical Collection* (U of T Press, 2019) as well as a special edition of the *Journal of Ethics and Mental Health* (2019).



**Dr. Dennis Kussin** founded and directed the Community Mental Health Program at the Toronto Western Hospital for over 20 years. Dr. Kussin has recently retired.



**Angela Robertson** is the executive director of Parkdale Queen West Community Health Centre.
